## CLOSURE OF NOTICE OF NON-PERFORMANCE

Mr. Daniel Kushner:

The Office of Energy Infrastructure Safety (Energy Safety) issued a Notice of Non-Performance (NON), NON\_ESD\_PGE\_RGA\_20260310\_0924 to Pacific Gas and Electric Company (PG&E) on April 3, 2026,<sup>1</sup> pursuant to Public Utilities Code section 326 and Government Code section 15475.1. PG&E submitted its response on May 4, 2026,<sup>2</sup> addressing the identified deficiency.

After reviewing the response, Energy Safety has determined that PG&E has adequately addressed Energy Safety's concerns. As a result, NON\_ESD\_PGE\_RGA\_20260310\_0924 is closed, and no further action on this matter is required by PG&E.
