

SCA Requirement

Public Utility Code Section 8389(d)(4):
 CPUC shall adopt and approve (by Dec. 1, 2020, and annually thereafter):

"A process for the division to conduct annual safety culture assessments for each electrical corporation."

Basis for 2023 SCA Guidelines

- Nov. 2020: CPUC adopted initial SCA process in Resolution WSD-011
- Dec. 2021: CPUC adopted revised SCA process in Resolution M-4860
- Dec. 2022: CPUC adopted revised SCA process in Resolution SPD-6
- Clarification of terms but no substantive changes in these revisions

SCA Purpose

- Assess safety outcomes over time, "foster continuous and collaborative improvement and learning" (WSD-011 Attachment 4)
- Companies requesting a safety certification can agree to implement the findings of the SCA report to establish "good standing"


SCA Core Components

- Workforce survey (Large IOUs and SMJUs)
- Management self-assessment (Large IOUs)
 - Summary plan for the coming year
- Interviews to better understand workforce survey and management self-assessment (Large IOUs)
- Safety culture objectives, lessons learned, report on previous year's
 SCA recommendations (Large IOUs, SMJUs, ITOs)

Changes: Removal of Unnecessary Language

- In 2023, passages that provide redundant or unnecessary information have been deleted from the SCA Guidelines
 - For example, the description of Energy Safety's intentions regarding the SCA process has been removed from the Introduction ("Energy Safety's assessment of safety culture is intended to be complementary to, and not a replacement for, ongoing work to improve safety culture at each electrical corporation")

Changes: Clarification about Role of the Third-Party Administrator

- New in 2023: Section 1 "The Role of the Third-Party Administrator in the Safety Culture Assessment Process"
 - "Energy Safety conducts its Safety Culture Assessment process through a third-party administrator. Use of a third-party for these activities provides Energy Safety with expertise in industrial safety culture assessments, assistance in refining the SCA process, and minimizes bias in the data collection process."

Changes: Clarification about Workforce Survey Communication

- Instructions for communicating about the workforce survey in 2022
 - "Below are guidelines for communication directed at the target survey population about the survey"
- Instructions in 2023
 - "In communicating with the target population about the survey, Energy Safety's third-party administrator and the electrical corporations must"

Changes: Removal of Terminology Definitions in Footnotes

• In 2023, terminology is defined in the Glossary but not additionally provided in footnotes throughout the SCA Guidelines


