ADOPTION MEETING FOR 2025 WILDFIRE MITIGATION PLAN UPDATE GUIDELINES

The Office of Energy Infrastructure Safety (Energy Safety) will hold a public meeting on Wednesday, January 31, 2024, for the adoption of the 2025 Wildfire Mitigation Plan (WMP) Update Guidelines. Energy Safety will take public comment, present an overview of the changes, and consider adoption of the 2025 WMP Update Guidelines and associated revised 2023-2025 WMP documents. The documents to be discussed and considered for adoption are:

- 2025 Wildfire Mitigation Plan Update Guidelines
- Revised 2023 – 2025 Wildfire Mitigation Plan Process and Evaluation Guidelines
- Revised 2023 – 2025 Electrical Corporation Wildfire Mitigation Maturity Model
- Revised 2023 – 2025 Electrical Corporation Wildfire Mitigation Maturity Survey
