Subject: Revised 2025 Wildfire Mitigation Plan Update Schedule

Dear Wildfire Mitigation Plan Stakeholders:

The Office of Energy Infrastructure Safety (Energy Safety) has revised its 2025 Wildfire Mitigation Plan (WMP) Update Schedule specifically for Group 1 electrical corporations.¹ The original schedule,² published on January 26, is replaced by Attachment 1 herein.

Group 1 electrical corporations will now submit their 2025 WMP Updates on April 2, 2024, rather than April 1, 2024. Subsequent dates for Group 1 electrical corporations' 2025 WMP Update schedule are adjusted accordingly. The date by which Energy Safety expects to issue draft Decisions on Group 1 electrical corporations 2025 WMP Updates is now July 2, 2024. There is no change to the WMP Update schedule for Group 2 electrical corporations.³

The revised schedule is presented in Attachment 1 to this letter with the date changes for Group 1 electrical corporations shown in bold.
