Mr. Marconi:

Bear Valley Electric Service, Inc. (BVES) submitted its 2025 Wildfire Mitigation Plan Update (2025 WMP Update) and revised 2023-2025 Base Wildfire Mitigation Plan (2023-2025 Base WMP) (redlined and clean versions) to the Office of Energy Infrastructure Safety's (Energy Safety) 2023-2025 WMPs docket on April 1, 2024. BVES submitted a revision per Energy Safety's Rejection and Order to Resubmit¹ to the same docket on May 29, 2024.²

Notice on Errata for BVES 2025 WMP Update

BVES must revise its 2025 WMP Update R1 and 2023-2025 Base WMP R1 (both redlined and clean versions) to correct the substantive and non-substantive errors identified in Appendix A. BVES must submit its newly Revised 2025 WMP Update and Revised 2023-2025 Base WMP to Energy Safety’s 2023-2025 WMPs docket by July 22, 2024.

BVES must not make any changes to its WMP beyond corrections to the errors listed in this request. BVES’s resubmitted 2025 WMP Update will be the subsequent version of its 2025 WMP Update submission and must be named accordingly, e.g., BVES 2025 WMP Update Revision 2.

Comments on BVES’s resubmitted 2025 WMP Update must be provided in accordance with Energy Safety’s Revised 2023-2025 WMP Process and Evaluation Guidelines.³ For BVES only (not for other Group 1 electrical corporations), the schedule below supersedes the revised schedule published by Energy Safety on June 21, 2024.⁴
