



Energy Safety to Hold Virtual Public Adoption Meeting for Proposed Updates to Wildfire Mitigation Plan Compliance Guidelines

The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public meeting on September 4, 2024, to consider adoption of proposed updates to its Wildfire Mitigation Plan (WMP) Compliance Guidelines. The public meeting will be held at 10 a.m. via Zoom (details below).

The WMP Compliance Guidelines, among other things, provide definitions and impose requirements that electrical corporations and independent evaluators must follow when submitting their Annual Reports on Compliance for the WMP compliance period. The document to be discussed and considered for adoption is:

- Proposed Updates to Wildfire Mitigation Plan Compliance Guidelines, with revisions

Energy Safety previously published proposed updates to the WMP Compliance Guidelines for public comment on June 5, 2024, with written comments due July 5, 2024. Energy Safety held a public meeting to present a summary of the written public comments and receive verbal public comments on July 16, 2024. No verbal comments were received during the meeting. Based upon the written comments received, Energy Safety published revisions to the proposed updates to the WMP Compliance Guidelines on July 26, 2024. Energy Safety is accepting comments on the revisions to the proposed updates to the WMP Compliance Guidelines through August 26, 2024.¹ Public comments will also be accepted during the
