Subject: 2026-2028 Base Wildfire Mitigation Plan Schedule

Dear Wildfire Mitigation Plan Stakeholders:

The schedule for the 2026-2028 Base Wildfire Mitigation Plan (WMP) submissions and evaluations is presented in Attachment 1 to this letter.

Public Utilities Code section 8386.3(a) requires Energy Safety to “approve or deny each wildfire mitigation plan and update submitted by an electrical corporation within three months of its submission, unless the division makes a written determination, which shall include reasons supporting the determination, that the three-month deadline cannot be met.”¹

Energy Safety will conduct a pre-submission check on each electrical corporation’s pre-submitted WMPs (pre-submissions).^{2,3} Following this pre-submission check, each electrical corporation will submit its WMP for the statutory evaluation process.⁴ The 2026-2028 Base WMP schedule in Attachment 1 covers the pre-submission check and the evaluation of the electrical corporations’ 2026-2028 Base WMPs. This schedule applies to all electrical corporations.
