## **Adoption Meeting for the 10-Year Electrical Undergrounding Plan Guidelines**

The Office of Energy Infrastructure Safety (Energy Safety) will hold a public meeting on February 20, 2025, to consider adoption of the 10-Year Electrical Undergrounding Plan Guidelines pursuant to Public Utilities Code sections 8385 and 8388.5. This meeting will be remote only. Energy Safety will present an overview of the 10-Year Electrical Undergrounding Plan Guidelines, take public comment, and consider adoption of the 10-Year Electrical Undergrounding Plan Guidelines.

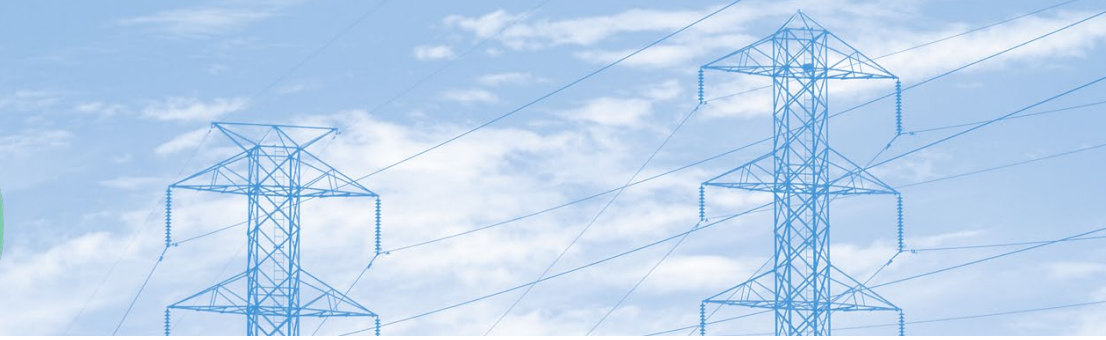
