



2. Maturity Survey Excel Spreadsheet



OVERVIEW OF MM/MS GUIDELINES (3 OF 4)

The **Maturity Model** is:

- A quantitative method to assess EC wildfire risk mitigation capabilities and examine how ECs propose to continuously improve in key areas of the WMP
 - Organized into 7 categories with 38 total capabilities

The three main objectives of the Maturity Model are:

1. Provide a tool to measure an EC's maturity in mitigating wildfire and outage risk
2. Drive year-over-year continual improvement
3. Create a quantitative history of EC maturity growth for examination in future years

The **Maturity Survey** is an Excel workbook tool to enable an EC to report its existing and planned maturity level for each sub-capability of the Maturity Model



- Published first draft of MM/MS Guidelines Package on 2/10/25
 - Received written comments from SDG&E, PG&E, and SCE (jointly) on 3/3/25
 - Question-and-Answer Session held on 3/11/25
 - No reply comments received on 3/12



Overview of Clarifying Changes from Draft to Final

CHANGES (DRAFT TO FINAL)



- **Throughout Capabilities:**
 - Clarified “minimum Energy Safety requirements” where applicable (throughout capabilities)
 - *Joint-IOU comment*
- **Capability 12; Transparency sub-capability**
 - Updated “facility guidelines” to “facility design and operation” to be consistent with sub-capability language
 - *Joint-IOU comment*
- **Capability 32; Comprehensiveness sub-capability**
 - Clarified emergency support services for “impacted” customers
 - *Joint-IOU comment*
