The Office of Energy Infrastructure Safety (Energy Safety) will hold a public meeting to consider adoption of the proposed updates to its Wildfire Mitigation Plan (WMP) Compliance Guidelines. The WMP Compliance Guidelines, among other things, provide definitions and impose requirements that electrical corporations and independent evaluators must follow when submitting their Annual Reports on Compliance for the WMP compliance period.
