On October 21, 2025, The Office of Energy Infrastructure Safety (Energy Safety) issued a Revision Notice on Liberty's 2026-2028 Base Wildfire Mitigation Plan (WMP). Per the Energy Safety Revision Notice, Liberty is required to submit a Revision Notice Response, including an updated 2026-2028 Base WMP, by November 20, 2025. Pursuant to the Energy Safety Policy Division Process Guidelines, Liberty requests an extension on submitting its Revision Notice Response and updated 2026-2028 Base WMP to December 4, 2025.

Liberty requests an extension for the following reasons:

- On Monday, November 3, 2025, Liberty activated an Incident Management Team (IMT) for a potential Public Safety Power Shutoff (PSPS) event on November 5, 2025. On Wednesday, November 5, 2025, Liberty initiated the PSPS event, which is expected to last through Thursday November 6. For the safety of Liberty's customers, this event requires near full-time participation from many of the same subject matter experts (SMEs) that are involved in developing Liberty's response to the Energy Safety Revision Notice. Additionally, the same SMEs will be involved in Liberty's post event reporting for this PSPS event, which will likely have the same due date of November 20, 2025.
- The critical issues identified by Energy Safety regarding Liberty's risk model require engagement with a third party to review elements of Liberty's wildfire risk model and rerun the model to generate improved outputs. Liberty needs additional time to engage with the third party, rerun the risk model, review the outputs, and assess and incorporate the impacts to Liberty's revision notice response and updated 2026-2028 Base WMP.
- The week of November 24, 2025 is Thanksgiving week and some of Liberty's SMEs will be out of office during part or all of that week. Therefore, Liberty requests a two-week extension instead of a one-week extension. Additionally, a one-week extension would result in Liberty's response being due on Thanksgiving Day.
