Energy Safety to Hold Virtual Public Meeting for Proposed Updates to Wildfire Mitigation Plan Performance Guidelines

SACRAMENTO - The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public meeting (via Microsoft Teams) on December 1st, at 1 p.m. to consider proposed revisions to its Wildfire Mitigation Plan (WMP) Performance Guidelines. The WMP Performance Guidelines provide definitions and requirements that electrical corporations and independent evaluators must follow when submitting their Annual Implementation Reports (AIRs). The document to be discussed is:
