## SUBJECT: Notice on Errata for the LS Power Grid California 2026-2028 Base Wildfire **Mitigation Plan**

## Mr. Fredkin:

LS Power Grid California's (LSPGC) submitted its 2026-2028 Base Wildfire Mitigation Plan (2026-2028 Base WMP) to the Office of Energy Infrastructure Safety's (Energy Safety) 2026-2028 Base WMPs docket (#2026-2028-Base-WMPs) on July 25, 2025. 1, 2 Energy Safety identified non-substantive errors listed in Table 1 of this Notice on Errata for LSPGC to correct.

LSPGC submitted errata to its 2026-2028 Base WMP on August 8, 2025, and September 8, 2025. Following LSPGC's resubmission, Energy Safety identified non-substantive errors that remain for LSPGC to correct.3

LSPGC must revise its 2026-2028 Base WMP R0 to correct the errors identified in Table 1, herein. LSPGC must submit its revised 2026-2028 Base WMP to Energy Safety's 2026-2028 Base WMPs docket by November 21, 2025.

If LSPGC, during its review, identifies additional non-substantive errors (spelling, grammar, etc.), it may make corrections to its 2026-2028 Base WMP beyond those listed in Table 1. If LSPGC makes additional corrections, it must provide a list of each correction in its cover letter that will accompany its response to this Notice on Errata.

Throughout		Make all corrections in an updated LSPGC 2026-2028 Base WMP R1 that LSPGC provided in the LSPGC Substantive/Non-Substantive Errata, <sup>4</sup> with the exception of target units in Table 9-2 as noted below.
		In Table 9-2. Vegetation Inspections and Pole Clearing Targets by Year, LSPGC used incorrect units in the LSPGC Substantive/Non-Substantive Errata for the "Target Unit" column under certain activities. For VM-05 and VM-06, the units must be "Circuit Miles Inspected," as required in the WMP Guidelines.
		LSPGC must update its 2026-2028 Base WMP to incorporate all errata corrections provided by LSPGC with the exception of the incorrect units referenced above, which it must correct to the target units as required by the WMP Guidelines.
Section 6	52	In Section 6.1.3, Activity Selection Process, LSPGC stated that it is in the process of creating and implementing more formal processes to identify and select appropriate wildfire mitigation activities and to monitor WMP implementation. In response to a data request, LSPGC provided a timeline: development beginning Q4 2026, refinement in 2027, and finalization in Q2 2028 to support the next base WMP cycle.

LSPGC must move the content currently labeled as Section 9.2.3, Emergency/Storm Event Inspections, to Section 9.9, Activities Based on Weather Conditions, and ensure that related overview, procedures, scheduling, and update details are incorporated into the existing sub-sections of Section 9.9.
