RE: PacifiCorp's Response to Notice of Non-Performance – PC_AKM_20250911_0924

Dear Sheryl Bilbrey:

PacifiCorp (PacifiCorp or Company) provides the following response to the finding identified in the “Notice of Non-Performance, “*NON_ESD_PC_AKM_20250911_0924*” (NON) issued by the Office of Energy Infrastructure Safety (Energy Safety) on November 6, 2025. On September 11, 2025, Energy Safety conducted an inspection of PacifiCorp’s WMP initiatives in the vicinity of the city of Sims, California.

Energy Safety found the following deficiency:

Deficiency 1. Energy Safety observed that in implementing 2025 WMP initiative 8.2.3.1.1 Wood and Slash Management, PacifiCorp failed to adhere to its protocol of managing wood and slash near Pole ID 00194900-06237004, Vegetation Management ID DN_Insp_2025_5G97 at coordinates 41.082722, -122.358831. Energy Safety considers this non-performance to be in the Minor risk category.

PacifiCorp Response:

In response to the NON, the company conducted a site review and completed all necessary cleanup activities in accordance with PacifiCorp’s standard operating procedures. Debris removal was carried out on November 14, 2025, ensuring that all materials were properly cleared and disposed of following established guidelines. Following the debris removal, the site underwent a final cleanup to confirm compliance with Pacific Power’s operational and environmental standards.
