On July 23, 2025, PacifiCorp d/b/a Pacific Power (PacifiCorp or Company) submitted its Annual WMP Data Submission Workbook. PacifiCorp now submits PC\_2026-WMP\_R1, the first revision to the annual WMP workbook in response to the Office of Energy Infrastructure Safety's October 13, 2025, Revision Notice for PacifiCorp's 2026-2028 Base WMP,<sup>1</sup> with the following updates:

- In response to data request OEIS-P-WMP 2025-PC-08, question 3a., PacifiCorp committed to provide an updated Table 11 to ensure projected expenditures match the projected expenditures in Table 3-3 in the Base WMP. Table 11 has been updated to aligned with Table 3-3 in the Base WMP.
