SUBJECT: Revised Independent Evaluator Lists for 2025 Wildfire Mitigation Plans

Following the review of applications received in consultation with the California Department of Forestry and Fire Protection's Office of the State Fire Marshal (CAL FIRE), the Office of Energy Infrastructure Safety (Energy Safety) has established nine Electrical Corporation (EC) specific lists of qualified Independent Evaluators (IEs) for the 2025 Wildfire Mitigation Plan (WMP) reviews. ECs may only contract with IEs on their respective EC-specific list (IE List) for the 2025 WMP reviews. The individuals and firms that appear on any of the nine IE lists have the requisite experience for assessing the safe operation of electrical infrastructure necessary to complete the independent reviews.

Background

By March 1 each year, Energy Safety, in consultation with CAL FIRE, makes available a list of qualified IEs with experience in assessing the safe operation of electrical infrastructure. Each electrical corporation shall, within 60 days of this announcement, engage an IE from their respective list to review and assess the electrical corporation's implementation of their WMP commitments. The engaged IE shall consult with, and operate under the direction of, Energy Safety.

Costs incurred for hiring listed IEs is the sole responsibility of the EC and not Energy Safety nor CAL FIRE.

Independent Evaluator Lists for 2025 WMPs

Each IE has been assessed and approved based on the criteria found within the Request for Qualifications (RFQ) 25-036882 that was posted to www.CaleProcure.ca.gov on October 30, 2025.¹ This announcement containing the nine EC-specific IE Lists for the 2025 WMP reviews has been filed to the respective docket in the Energy Safety e-Filing System.²
