## NOTICE OF NON-PERFORMANCE

Mr. Jones:

Pursuant to Government Code section 15472, et seq, the Office of Energy Infrastructure Safety (Energy Safety) has conducted an inspection of work completed by PacifiCorp (PC) in accordance with its 2024 Wildfire Mitigation Plan (WMP) and determined the existence of non-performance requiring correction. Energy Safety therefore issues PC a Notice of Non-Performance (NON), identifying non-performance with its approved WMP.

On May 22, 2025, Energy Safety conducted an inspection of PacifiCorp's WMP initiatives in the vicinity of the city of Yreka, California. The inspection report is enclosed herewith. Energy Safety found the following deficiency:

Deficiency 1. Energy Safety observed that in implementing 2024 WMP initiative 8.1.2.12 - Expulsion Fuse Replacements, PC failed to complete the installation of CAL FIRE-approved non expulsion fuses on Pole ID 624507.272701, Grid Hardening ID 7074439 at coordinates 41.7241174853914, -122.645554862033. Energy Safety considers this non-performance to be in the Minor risk category. PC must complete a corrective action for this deficiency by 12 months from date of this notice.<sup>1</sup>

Within 30 days from the issuance date of this NON, the electrical corporation must provide a response advising Energy Safety of corrective actions taken or planned to remedy the above identified deficiency.

This response shall be filed in the Energy Safety e-Filing system under the 2024 NON Docket<sup>2</sup> and the associated file name(s) must begin with the NON identification number.

Prior to its response, the electrical corporation may also request an informal conference with Energy Safety for the purpose of disputing any issues raised in this NON no later than five (5) business days before the

# INSPECTION REPORT

## Overview

### Inspection Categories

The Office of Energy Infrastructure Safety (Energy Safety) conducts inspections to verify the work performed by an electrical corporation as reported in an approved Wildfire Mitigation Plan (WMP) or subsequent filing, and to assess general conditions of electrical infrastructure that may adversely impact an electrical corporation's wildfire risk.

A Notice of Non-Performance (NON) is issued for any deficiencies discovered during an inspection related to an electrical corporation's execution of its WMP initiatives.

### Correction Timelines

Deficiencies must be corrected in a timely manner. Energy Safety may prescribe a timeframe for resolution of a deficiency.<sup>4</sup> If Energy Safety assigns a risk category to a deficiency, an electrical corporation must correct the deficiency as required per the timelines provided in Table 1.<sup>5</sup>

**Table 1. Risk Category and Correction Timelines**

Risk Category	Deficiency correction timeline
Severe	<ul style="list-style-type: none"><li>• Immediate resolution</li></ul>
Moderate	<ul style="list-style-type: none"><li>• 2 months (in High Fire Threat District (HFTD) Tier 3)</li><li>• 6 months (in HFTD Tier 2)</li><li>• 6 months (if relevant to worker safety; not in HFTD Tiers 2 or 3)</li></ul>
Minor	<ul style="list-style-type: none"><li>• 12 months or resolution scheduled in WMP update</li></ul>

# Inspection Details

## Deficiency 1

### **Relevant Requirement:**

PC's WMP states the following regarding initiative number 8.1.2.12 – Expulsion Fuse Replacements:

1. “This is a project to install new and CAL FIRE-approved non expulsion fuses including power fuses and current limiting fuses to replace existing expulsion fuse equipment with planned end date in 2024.”<sup>6</sup>

### **Finding:**

On Pole ID 624507.272701, Grid Hardening ID 7074439 at 935 Shasta Ave, Yreka, CA, 96097, USA, 41.7241174853914, -122.645554862033, the inspector observed that California Department of Forestry and Fire Protection (CAL FIRE)-approved non expulsion fuses were not installed in the cutouts. The inspector's observation is documented in Deficiency 1 photographs, which are attachments to this report. Photo numbers Item1GIImg1, Item1IA1Img1, and Item1IA1Img2 depict incomplete installation of CAL FIRE-approved non expulsion fuses. In the 2024 Q4 Quarterly Data Report submission, PC reported that work on WMP initiative 8.1.2.12 – Expulsion Fuse Replacements were completed at this location on Pole ID 624507.272701, Grid Hardening ID 7074439.

Energy Safety concludes there is a deficiency because of these facts:

1. Two of three CAL FIRE-approved non expulsion fuses were not installed in the cutouts.
2. Two fuses were observed hanging from the pole.
