**SUBJECT: Notice on Errata for the Southern California Edison Company 2026-2028 Base Wildfire Mitigation Plan**

Mr. Ferree:

Southern California Edison Company (SCE) submitted its 2026-2028 Base WMP Wildfire Mitigation Plan (2026-2028 Base WMP) to the Office of Energy Infrastructure Safety's (Energy Safety) 2026-2028 Base WMPs docket (#2026-2028-Base-WMPs) on October 27, 2025.<sup>1,2</sup> Energy Safety identified non-substantive errors listed in Table 1 of this Notice on Errata for SCE to correct.

SCE submitted a revised 2026-2028 Base WMP in response to Energy Safety's Revision Notice to the same docket (#2026-2028-Base-WMPs) on September 15, 2025. SCE submitted a second revised 2026-2028 Base WMP and non-substantive errata to the same docket (#2026-2028-Base-WMPs) on October 27, 2025. Following SCE's resubmissions, Energy Safety identified non-substantive errors that remain for SCE to correct.<sup>3</sup>

**SCE must revise its 2026-2028 Base WMP R2 to correct the errors identified in Table 1, herein. SCE must submit its revised 2026-2028 Base WMP to Energy Safety's 2026-2028 Base WMPs docket by January 22, 2026.**

If SCE, during its review, identifies additional non-substantive errors (spelling, grammar, etc.), it may make corrections to its 2026-2028 Base WMP beyond those listed in Table 1. If SCE makes additional corrections, it must provide a list of each correction in its cover letter that will accompany its response to this Notice on Errata.

Section	WMP Page Number	Correction or Clarification
Table of Contents	Starting on page i	SCE must update the table of contents page number references to accurately reflect the correct WMP Sections, subsections, and page numbers throughout the WMP.
Section 13.3 Discontinued Activities	Page 502	<p>In its response to Data Request 18, Question 3, SCE stated that its SH-10 and SA-10 activities are experiencing delays and may have work scoped for 2026 or beyond.<sup>4</sup></p> <p>SCE must revise Section 13.3 of its 2026-2028 Base WMP to remove the SH-10 and SA-10 activities consistent with its response to Data Request 18, Question 3.<sup>5</sup></p>
Section 9.12 Work Orders	Page 375	The summation of all past due work orders in <i>Table 9-7: Number of Past Due Vegetation Management Work Orders Categorized by Age and HFTD Tier</i> (16,735) is not the same as the summation of all past due work orders in <i>Table 9-8: Number of Past Due Vegetation Management Work Orders Categorized by Age and Priority Levels</i> (14,136) in the 2026-2028 Base WMP.

		<p>SCE addressed this discrepancy in its response to Data Request 17, Question 2, where SCE explained that this is because Table 9-7 erroneously includes the category “<math>\geq</math>GRCD (grid resiliency clearance distance),” and Table 9-8 does not include this category.<sup>6</sup></p> <p>The summation of all past due work orders within each table, Table 9-7 and Table 9-8, should be identical. SCE must adjust Table 9-7 and/or Table 9-8 so that past due vegetation management work order totals for each table are the same.</p>
Section 9.2.1.5 Scheduling, and Section 9.2.2.5 Scheduling	Pages 339 and 342.	<p>SCE introduced equivocating language in Sections 9.2.1.5 and 9.2.2.5 that appeared to dilute its vegetation management commitments.<sup>7</sup> SCE clarified this statement in its response to Data Request 18, Question 1, by explaining that “[w]hile the timing of inspection work may not always adhere to the original planned schedule, it is ultimately completed.”<sup>8</sup> Furthermore, SCE responded in the same Data Request response, Question 2, that inspection “work is monitored to ensure completion.”<sup>9</sup></p> <p>SCE must update its 2026-2028 Base WMP to include the clarifications made in its response to Data Request 18, Questions 1 and 2.</p>
