**RE: PacifiCorp's Response to Notice of Non-Performance –
PAD_PC_RMA_20251007_1050**

Dear Patrick Doherty:

PacifiCorp provides the following response to the finding identified in the “Notice of Non-Performance, “NON_PAD_PC_RMA_20251007_1050” (NON) issued by the Office of Energy Infrastructure Safety (Energy Safety) on January 23, 2026. On October 7, 2025, Energy Safety conducted an inspection of PacifiCorp’s WMP initiatives in the vicinity of the city of Montague, California.

Energy Safety found the following deficiency:

Deficiency 1. Energy Safety observed that in implementing the 2025 WMP initiative - 8.1.2.12 - Expulsion Fuse Replacements, PC failed to complete the installation of CAL FIRE-approved non expulsion fuses on pole associated with Grid Hardening ID 7112939, at coordinates 41.7058549755094, -122.564514. Energy Safety considers this non-performance to be in the Minor risk category. PC must complete a corrective action for this deficiency by 12 months from the date of this notice.

PacifiCorp Response:

In response to the notice of non-performance, the company conducted a field inspection on January 29, 2026, of Solid blades that exist at this location. In 2024, PacifiCorp was reporting these as complete; however, Cal Fire has not updated their standard to accept solid blades as non-exempt for line fuses. Based on this, PacifiCorp has stopped counting similar installations as complete units, but we are leaving them as installed.
