SUBJECT: Independent Evaluator Enlistment Announcement

To Whom It May Concern:

In accordance with Public Utilities Code (PU Code) 8386.3(c)(2)(A), by March 1, 2021 the California Public Utilities Commission's (CPUC's) Wildfire Safety Division (WSD), in consultation with the California Department of Forestry and Fire Protection's (CAL FIRE) Office of the State Fire Marshal (OSFM), shall make available a list of qualified IEs with experience in assessing the safe operation of electrical infrastructure. This correspondence is to announce the enlisted independent evaluators (IE) that are approved to perform the work as stipulated in PU Code 8386.3(c)(5)(C) and as outlined in the scope of work in RFQ 20NC0427.
