SUBJECT: Revised Independent Evaluator Enlistment Announcement

To Whom It May Concern:

In accordance with Public Utilities Code (PU Code) 8386.3(c)(2)(A), by March 1, 2022 the Office of Energy Infrastructure Safety (Energy Safety), in consultation with the California Department of Forestry and Fire Protection's (CAL FIRE) Office of the State Fire Marshal (OSFM), shall make available a list of qualified independent evaluators (IE) with experience in assessing the safe operation of electrical infrastructure. This correspondence is to announce an addition to the enlisted IEs that are approved to perform the work as stipulated in PU Code 8386.3(c)(5)(C) and as outlined in the scope of work in the Request for Qualifications (RFQ) 21-89482. This additional IE has been added as a result of reposting RFQ 21-89482, as previously discussed in the initial IE enlistment announcement posted on January 24, 2022.

Each electrical corporation shall engage an IE listed to review and assess the electrical corporation's compliance with its' wildfire mitigation plan (WMP), as outlined in the scope of work in RFQ 21-89482. The engaged IE shall consult with, and operate under the direction of, Energy Safety. Costs incurred for hiring listed IEs shall be the sole responsibility of the electrical corporation and not Energy Safety or CAL FIRE.
