

Errata to Pacific Gas and Electric Company's 2022 Wildfire Mitigation Plan

Pacific Gas and Electric Company (PG&E) has identified a limited number of updates to the 2022 Wildfire Mitigation Plan (2022 WMP), Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01.xlsx, submitted February 25, 2022. The updates are described below, and the revised attachment has been posted to the PG&E Wildfire Mitigation Plan website: www.PGE.com/wildfiremitigationplan (WMP Website).

The tables below summarize the changes made to the updated attachment.

- **Table 1:** Provides a summary of financial updates included in Revision 1 of Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01_R1, Table 2 and Table 12.
- **Table 2:** Provides a summary of updates to RSE reported values included in Revision 1 of Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01_R1, Table 12.

Because it is not practical to show entire tables in a summary table format, most of the updates are described rather than fully shown in a redline format. In the Updated Attachment R1, all of changes in the tables are reflected in **Orange Highlight** and only the tabs that have been highlighted orange have been updated from the original submission. Understanding that stakeholders may want to compare the old tables to the updated tables, PG&E has retained a copy of the original version of Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01.xlsx on the WMP website as Revision 0 (R0).

PG&E notes that this attachment contains the same tables as the Quarterly Metrics submission template.¹ PG&E is similarly submitting an updated Quarterly Metrics file with the updates described below in Tables 2 and 12 as 20220225_PGE_2021_Q4Metrics_R3.

¹ PG&E's 2021 WMP Final Action Statement required PG&E to "separate HFRA from its non-HFTD costs, presented in the format of WMP Table 12." (See PG&E 2021 WMP Final Action Statement, p.47). PG&E included this HFRA costs broken out in Table 12 in Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01_R1.xlsx. The Table 12 in 20220225_PGE_2021_Q4Metrics_R3 is in the format required by Attachment 3 of the 2022 WMP guidelines. All cell locations are in reference to Attachment 2022-02-25_PGE_2022_WMP-Update_R0_Section 7.3.a_Atch01_R1.xlsx.
