SUBJECT: PacifiCorp 2022 Wildfire Mitigation Plan Data Submittal

Ms. Kishore,

Pursuant to Energy Safety's Final 2022 Wildfire Mitigation Plan (WMP) Update Guidelines,¹ adopted on December 14, 2021,² utilities are required to submit their 2022 First Quarter (Q1) Quarterly Data Reports (QDRs) by May 1, 2022.

The 2022 WMP Guidelines provided a schedule and instructions for QDR submissions (included in Attachment 5), which required that non-spatial data submissions were to follow the schema of *Attachment 3: 2022 Performance Metrics Data Templates*. Further, the final 2022 WMP Guidelines removed the requirement for utilities to submit updated data, including 2022 and 2023 projections, concurrent with submission of a WMP.

Energy Safety reached out to PacifiCorp to request that all available spatial and non-spatial data associated with PacifiCorp's 2022 WMP filing be submitted on April 15, 2022. For any data that is not available on April 15, 2022, Energy Safety requested that PacifiCorp submits this as part of its Q1 QDR submission on May 1, 2022. In response to Energy Safety's request, PacifiCorp confirmed that the non-spatial data requirements can be submitted according to the timescale below:

This is providing the data is submitted in the updated format and with the new breakouts (High Fire Threat District (HFTD), non-HFTD) and also includes projections.
