Dear Wildfire Mitigation Plan stakeholders,

On December 15, 2021, the Office of Energy Infrastructure Safety (Energy Safety) issued the 2022 Wildfire Mitigation Plan (WMP) Guidelines (Guidelines). This document is an addendum to Attachment 5 of the Guidelines that specifies reply comment due dates and describes how utilities will provide a weekly summary of data requests.

Draft Decision Reply Comment Due Dates

The deadlines for reply comments on Energy Safety's Draft Decisions for Pacific Gas and Electric Company (PG&E), Southern California Edison Company (SCE), and San Diego Gas & Electric Company (SDG&E) (Large Utilities) WMPs were inadvertently omitted from the Guidelines.² The revised table is below, which outlines the 2022 WMP Update submission and evaluation timeline for the Large Utilities. Revisions include the addition of reply comment deadlines on Energy Safety's Draft Decisions for each of the Large Utility's WMPs; there are no other changes to the timeline.

Data Request Weekly Summaries

Attachment 5 of the Guidelines require utilities to post all data request responses to their web page on a weekly basis, as well as maintain a discovery log that lists all discovery or data requests it receives on its 2022 WMP Update.

In addition, in the interest of full disclosure, Energy Safety emailed the Large Utilities in early-March 2022 and directed them to submit a weekly summary of data requests and data request responses to the docket #2022-WMP-DRs. Weekly summaries are due to the docket each Thursday by close of business.

Following their 2022 WMP Update submissions on May 6, 2022, the Small and Multi-jurisdictional Utilities (SMJUs) and Independent Transmission Operators (ITOs) will also be required to submit weekly data request summaries according to the same process above.

Note that the summaries will not contain specific data requests and responses but will summarize the requests received that week. Each summary will include where to find the specific data requests, including the URL of each utility's respective 2022 WMP Update web page, the location of the data requests and responses on the page, and the date of each data request and data request response. Each utility will submit weekly summaries through the date of publication of Energy Safety's 2022 WMP Update Final Decision.
