Third Errata to Pacific Gas and Electric Company's 2022 Wildfire Mitigation Plan

Pacific Gas and Electric Company (PG&E) has identified a limited update to the 2022 Wildfire Mitigation Plan (2022 WMP):

- Update to the target language for the pole clearing program, which occurs in two locations in the WMP: Table PG&E-5.3-1(A) and Section 7.3.5.2.
- Minor footnote correction to Table PG&E-7.1.E-1 (p. 328)

These updates are described below.

Summary of Updates to 2022 Wildfire Mitigation Plan

Issue: We have identified that a revision to the WMP target for our pole clearing program (E.02, Section 7.3.5.2) is necessary. Specifically, we modified the target completion date from April 30, 2022, to October 1, 2022. In addition, we revised the general phrase "complete work" to "inspect and clear (where clearance is needed)" which more precisely describes the work that will be performed in this initiative. Finally, we updated the completion date for newly discovered assets so that all inspection and clearance work (when needed) under this initiative will be finished by the target due date, or within 45 days of when the asset was added to the Vegetation Management Database for assets discovered after August 31, 2022.

Identical language describing this target occurs in two locations in the 2022 WMP. Below, we provided the updated language for both locations.

Issue: We have identified a minor error on page 328 of the WMP. On Table PG&E-7.1.E-1(New or Emerging Technologies), footnote (b) is correctly appears on page 329 stating: "For these three related projects (Line Sensors, Early Fault Detection, and Distribution Fault Anticipation), the forecast shown is capital costs only (no expense). The expense for these three projects is combined and is \$2,576." However, one of the three (b) footnotes referenced in the table is listed in error on page 328 next to "EPIC 3.45: Automated Fire Detection from Wildfire Alert Cameras." The correct location should be next to "Line Sensor Devices."

Location / Correction: Page 328, Table PG&E-7.1.E-1(New or Emerging Technologies). The (b) footnote to be removed from "EPIC 3.45: Automated Fire Detection from Wildfire Alert Cameras; \$1,983" and added to "Line Sensor Devices; \$8,037."
