Subject: Extension of the evaluation timeframe for San Diego Gas & Electric Company's 2022 Wildfire Mitigation Plan Update

Dear Wildfire Mitigation Plan Stakeholders:

San Diego Gas & Electric Company (SDG&E) timely submitted its 2022 Wildfire Mitigation Plan Update (WMP Update) on February 11, 2022. According to the statutorily mandated evaluation timeframe, Energy Safety must provide a determination on SDG&E's WMP Update by May 12, 2022, unless Energy Safety makes a written determination that this three-month deadline cannot be met.¹

Energy Safety finds that an extension of this deadline is necessary to complete its evaluation. During the public comment period, Energy Safety received substantial, substantive input from stakeholders. Energy Safety allowed the public to submit one set of comments on SDG&E, Southern California Edison, and Pacific Gas and Electric Company's WMPs. As a result, due to staggered submissions, Energy Safety received comments on SDG&E's WMP late in the threemonth evaluation cycle. To ensure input is sufficiently considered and incorporated into the evaluation, an extension of the timeframe to provide a determination is warranted.

Energy Safety hereby extends its deadline for publishing its draft decision on SDG&E's 2022 WMP Update for one week, to Thursday May 19, 2022.

After issuance of the draft decision, stakeholders and members of the public will have 20 days for comments and 10 days for reply comments, due on June 8, 2022, and
