ADOPTION MEETING FOR DATA GUIDELINES

The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public meeting on March 17, 2023, for the adoption of the Draft Data Guidelines. The Draft Data Guidelines are to ensure California’s electrical corporations submit uniform information for Wildfire Mitigation Plan (WMP) evaluation and compliance. Energy Safety will take public comment, present an overview of the changes, and consider adoption of the Data Guidelines. The documents to be discussed are:
