## Dear Program Manager Morgans:

Southern California Edison Company (SCE) provided its 2023-2025 Wildfire Mitigation Plan (WMP) Pre-Submission to the Office of Energy Infrastructure Safety (Energy Safety) on February 13, 2023. Energy Safety reviewed SCE's WMP Pre-Submission for completeness in accordance with Section 4.1 of the 2023-2025 Wildfire Mitigation Plan Process and Evaluation Guidelines.

On March 6, 2023, Energy Safety issued a determination letter stating that SCE's WMP Pre-Submission did not satisfy the completeness check. SCE has addressed the completeness check items (as shown in Appendix A). SCE has also made additional corrections to fix non-substantive errors (as shown in Appendix B).

SCE and Energy Safety have identified a limited number of non-substantive errors since submitting the WMP on February 13, 2023. The table below summarizes the non-substantive revisions made by SCE.<sup>1</sup>

SCE has endeavored to accurately update page number references as required in various tables in Sections 3, 8 and 9. Some page numbers, in particular the references to the end of a section, may be slightly off due to pagination changes in converting the document to PDF. However, internal hyperlinks within the PDF should take the reader to the correct page.
