## San Diego Gas & Electric Company's Quarterly Data Report on WMP Spatial and Non-Spatial Data (QDR)

April 5, 2023



Pursuant to the California Public Utilities Commission (Commission or CPUC) Resolution WSD-011, and Wildfire Safety Division's Compliance Operational Protocols, issued February 16, 2021, SDG&E hereby submits its revised Quarterly Data Report (QDR) for the period October 1, 2022 through December 31, 2022 (Q4). A copy of this report is being provided to the California Office of Energy Infrastructure Safety (OEIS) docket and the service list of Rulemaking (R.) 18-10-007.
