To Electric Safety Policy Division:

Pursuant to Section 4.3 of the 2023-2025 Wildfire Mitigation Plan (WMP) Process and Evaluation Guidelines (the Process Guidelines), Pacific Gas and Electric Company (PG&E) hereby submits our substantive errata for our 2023-2025 WMP. We have also included some non-substantive errata that has been identified to date, in an effort to expedite the correction process.<sup>1</sup>

The substantive errata in this submission include the following categories of items:

- Narrative updates/corrections;
- Figure and Table updates/corrections; and
- Target updates/corrections.

The non-substantive errata in this submission include the following categories of items:

- PDF corruption adjustments (outlined below).

PG&E discovered this week that a glitch with Adobe Acrobat caused an isolated issue where random characters/letters were missing from various locations throughout the March 27<sup>th</sup> submittal of our Public and Confidential WMPs.
