**RE: PacifiCorp (U 901 E) First Quarter 2023 Wildfire Mitigation Plan Quarterly Data Report**

Dear Director Jacobs:

PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) submits its first quarter 2023 (Q1 2023) Quarterly Data Report (QDR) pursuant to Energy Safety’s Final Wildfire Mitigation Data Guidelines – Version 3.0 (WMP Data Guidelines) adopted on December 14, 2022.<sup>1</sup> In accordance with Section 4.3.1 Table 1: Quarterly Initiative Update Data (QIU) of the WMP Guidelines, the QIU data is submitted as Table 1 of the QDR Template. The Company requested and received approval from Energy Safety to submit the spatial data portion of this QDR by May 8, 2023.

15	Top Risk Circuit Scores	<b>No “Blank Meaning” column in the table.</b> PacifiCorp is currently developing the risk assessment tools as part of its 2023-2025 WMP and anticipates the calculation of the “Top Risk Circuit Scores” will be completed and data
