

Overview of Safety Certification Guidelines

The Safety Certification Guidelines

Provide direction to electrical corporations on meeting the requirements of Public Utilities Code section 8389(e), which must be satisfied for Energy Safety to issue a Safety Certification.

Changes Made to the 2022 Safety Certification Guidelines for 2023

2023 Updates to the 2022 Safety Certification Guidelines (1/3)

- Streamlined the document to remove redundant language
- Additional requirements under "Board Safety Committee and Safety Reporting" relating to:
 - Safety committee member qualifications
 - Safety committee recommendations reporting

2023 Updates to the 2022 Safety Certification Guidelines (2/3)

- "Good standing" language streamlined
- "Implementation of WMP" language streamlined
- New "Reporting to Energy Safety" section with Quarterly Notification format
- New "Quarterly Notification Submission Dates" section
- New "Accessibility" section
- Revised "Safety Certification Timeline and Submission Instructions"

2023 Updates to the 2022 Safety Certification Guidelines (3/3)

"All electrical corporations seeking a Safety Certification must submit Safety Certification requests according to **a separate schedule** to be issued by Energy Safety each year."

Changes Made to the 2023 Draft Safety Certification Guidelines

Written Public Comments

- Draft Safety Certification Guidelines published May 3, 2023
- Comments received from SCE and SDG&E May 23, 2023
- Reply comments were due on Friday, June 2, 2023: Energy Safety received none

Changes to the Draft 2023 Safety Certification Guidelines

- Introduction clarifies timing of Safety Certification requests.
- Reporting section clarifies updates are not needed for implementation of long-term objectives in the Quarterly Notifications.
- Reporting section revised to clarify that Energy Safety does not need to see updates on all prior Safety Committee recommendations, only the outstanding ones.
