## RE: PacifiCorp (U 901 E) First Quarter 2023 Wildfire Mitigation Plan Quarterly Data Report – Revised

Dear Director Jacobs:

PacifiCorp d/b/a Pacific Power (PacifiCorp or the Company) resubmits its first quarter 2023 (Q1 2023) Quarterly Data Report (QDR) pursuant to Energy Safety's Final Wildfire Mitigation Data Guidelines – Version 3.0 (WMP Data Guidelines) adopted on December 14, 2022.<sup>1</sup> In accordance with Section 4.3.1 Table 1: Quarterly Initiative Update Data (QIU) of the WMP Guidelines, the QIU data is submitted as Table 1 of the QDR Template. The Company is submitting a revised QDR because the Company recently learned that the previous submission contained data that had been transposed incorrectly.
