**SUBJECT: Office of Energy Infrastructure Safety Issuance of Statement of Substantive Erratum for Bear Valley Electric Service Company’s 2023-2025 Wildfire Mitigation Plan**

Dear Mr. Marconi:

In accordance with the Office of Energy Infrastructure Safety’s (Energy Safety’s) 2023-2025 Wildfire Mitigation Plan Process and Evaluation Guidelines,<sup>1</sup> Energy Safety is asking Bear Valley Electric Service Company (BVES) to address a substantive erratum that Energy Safety found in reviewing its 2023-2025 Wildfire Mitigation Plan (Base Plan or WMP).

BVES must revise its WMP to address the following erratum:

- Correct the WMP Table 8-35 “Emergency Preparedness Initiative Targets by Year,” identified in Data Request OEIS-P-WMP\_2023-BVES-003, Question 2. BVES provided its response to this data request on July 10, 2023,<sup>2</sup> which confirmed the table in the submitted WMP was an error.

BVES must include a corrected Table 8-35 in its revised WMP, submitted in response to Energy Safety’s Revision Notice issued to BVES on August 8, 2023. BVES must submit its Revision Notice Response, inclusive of this substantive erratum, via email to the Program Manager of the Electric Safety Policy Division and to the 2023-2025 Wildfire Mitigation Plans docket (#2023-2025-WMPs) by Wednesday, August 23, 2023.<sup>3</sup> BVES must concurrently serve its Revision Notice Response to the California Department of Forestry and Fire Protection (CAL FIRE) at [CALFIREUtilityFireMitigationUnit@fire.ca.gov](mailto:CALFIREUtilityFireMitigationUnit@fire.ca.gov).
