Public Comment Period

The Office of Energy Infrastructure Safety (Energy Safety) today released Draft Compliance Guidelines Version 2 for public review and comment. For reference, Energy Safety has also provided a redline showing the changes to the guidelines from Version 1 to Version 2. The deadline for public comment is as follows:

Monday, August 21, 5 p.m. Pacific Time - 10 days from publication

Energy Safety will take public comment, present an overview of the changes made to the draft guidelines, and consider the adoption of the Compliance Guidelines.


