**SUBJECT: Office of Energy Infrastructure Safety Issuance of Statement of Substantive Erratum for PacifiCorp’s 2023-2025 Wildfire Mitigation Plan**

Dear Mr. Berreth:

In accordance with the Office of Energy Infrastructure Safety’s (Energy Safety’s) 2023-2025 Wildfire Mitigation Plan Process and Evaluation Guidelines,<sup>1</sup> Energy Safety requests that PacifiCorp address a substantive erratum that Energy Safety found in reviewing PacifiCorp’s 2023-2025 Wildfire Mitigation Plan (Base Plan or WMP).

PacifiCorp must revise its WMP to address the following:

- Correct Table 8-17<sup>2</sup> “Vegetation Management and Inspection Performance Metrics Results by Year” of its WMP with information from Data Request OEIS-P-WMP\_2023-PC-005, Question 1. PacifiCorp provided its response to this data request on August 18, 2023,<sup>3</sup> which confirmed the correct Quarterly Data Report (QDR) from which these metrics can be found and provided an updated Table 8-17, populated from its Q2 2023 QDR.
- Correct Table 8-5 “Grid Design, Operations, and Maintenance Performance Metrics Results by Year” of its WMP with information from Data Request OEIS-P-WMP\_2023-PC-005, Question 2. PacifiCorp provided its response to this data request on August 18, 2023,<sup>4</sup> which confirmed the correct QDR from which these metrics can be found and provided an updated Table 8-5 with data populated from its Q2 2023 QDR.

PacifiCorp must include the corrected Tables 8-17 and 8-5 in its revised WMP, submitted in response to Energy Safety's Revision Notice issued to PacifiCorp on September 11, 2023. PacifiCorp must submit its Revision Notice Response, inclusive of this substantive erratum, to the Energy Safety Deputy Director via email and to the 2023-2025 Wildfire Mitigation Plans docket (#2023-2025-WMPs) via Energy Safety's e-filing system by Wednesday, October 11, 2023.<sup>5</sup> PacifiCorp must concurrently serve its Revision Notice Response to the California Department of Forestry and Fire Protection (CAL FIRE) at [CALFIREUtilityFireMitigationUnit@fire.ca.gov](mailto:CALFIREUtilityFireMitigationUnit@fire.ca.gov).
