Description of Incident:

On April 25, 2016 at approximately 0930 hours, an outage occurred at PG&E's El Cerrito, Station G located at 7140 Schmidt Lane in the City of El Cerrito due to the failure of a cable that runs from the transfer bus to Station Service Transformer Bank# 1 (12kV/(120/240V))). The length of the cable was approximately 80 to 100 feet.

The cable failure caused Transformer Bank# 4, which is near the vicinity of Station Service Transformer Bank# 1 to relay and resulted in an outage to the following customers served by Transformer Bank# 4:

- 6,450 customers on the Berkeley F-402 circuit,
- 16,876 customers on the Berkeley F-1102 circuit,
- 3,399 customers on the Berkeley F-401 circuit, and
- 11,943 customers on the El Cerrito G-1101 circuit.

PG&E implemented switching and restored service to:

- 6,450 customers on the Berkeley F-402 by 1247 hours,
- 16,876 customers on the Berkeley F-1102 circuit by 1247 hours,
- 3,399 customers on the Berkeley F-401 circuit by 1250 hours, and
- 11,943 customers on the El Cerrito G-1101 circuit by 1301 hours.

The cause of the cable failure is unknown. The failed cable has been sent to Exponent for their analysis. PG&E re-routed the span of cables to feed the Station Service Transformer Bank# 1. Transformer Bank# 4 was placed back in service on April 28, 2016.

PG&E reported this incident to the CPUC on April 25, 2016 at 1119 hours under the Media Criterion due to several internet articles on this incident.
