The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public meeting on Tues., Jan. 30 from 9 a.m to 9:30 a.m., 2024, for the adoption of the Draft Data Guidelines v3.2.

The Draft Data Guidelines v3.2 are to ensure California’s electrical corporations submit uniform information for Wildfire Mitigation Plan (WMP) evaluation and compliance. Energy Safety will take public comment, present an overview of the changes, and consider adoption of the Data Guidelines v3.2. The documents to be discussed are:
