Subject: Request to Amend Bear Valley Electric Service, Inc. 2024 Maturity Survey Questions

Dear Deputy O'Rourke,

Pursuant to the Office of Energy Infrastructure Safety ("Energy Safety") 2023-2025 Wildfire Mitigation Plan Process and Evaluation Guidelines of December 6, 2022, Bear Valley Electric Service, Inc. ("BVES" or "Bear Valley") requests to amend its 2024 Maturity Survey response as indicated in this letter.

On June 10, 2024, Energy Safety informed BVES via Data Request OEIS-P-WMP_2024-BVES-004 that BVES did not respond to 61 questions in Category A – Risk Assessment and Mitigation Strategy in its 2024 response to the Maturity Survey. BVES reviewed the survey and agreed the questions had been unintentionally left blank. It was not BVES's intention to leave any questions blank. BVES initially skipped many risk-model-related survey questions pending technical support from its risk modeling contractor, Technosylva. BVES went back through each section to answer the skipped questions. It appears BVES did not save the responses correctly and hit the submit button before all the questions were fully answered. It was BVES's intention to answer all the questions and in fact has responses to the questions erroneously left blank. This omission was an administrative error. BVES has the responses to the skipped questions.

In order to ensure that the 2024 Maturity Survey is accurate and complete and to allow for survey trend analysis and continuity, BVES respectfully requests authorization to amend its 2024 Maturity Survey to provide responses to the following questions that were left blank: 1.1.5.Q9 (2024, 2025, 2026), 1.1.5.Q10 (2024, 2025, 2026), 1.1.6.Q1 (2024, 2025, 2026), 1.1.6.Q2 (2024, 2025, 2026), 1.1.6.Q3 (2024, 2025, 2026), 1.1.9.Q8 (2024, 2025, 2026), 1.1.10.Q8 (2024, 2025, 2026), 1.1.10.Q9 (2024, 2025, 2026), 1.2.2.Q14 (2024, 2025, 2026), 1.2.8.Q8 (2024, 2025, 2026), 1.2.8.Q9 (2024, 2025, 2026), 1.3.8.Q8 (2024, 2025, 2026), 1.3.8.Q9 (2024, 2025, 2026), 1.4.9.Q2 (2026), 1.4.9.Q8 (2024, 2025, 2026), 1.4.9.Q9 (2024, 2025, 2026), 1.4.9.Q10 (2024, 2025, 2026), 1.4.10.Q8 (2024, 2025, 2026), 1.4.10.Q9 (2024, 2025, 2026), 1.6.8.Q8 (2024, 2025, 2026), and 1.6.8.Q9 (2024, 2025, 2026).
