Subject: Revised Schedule for 2025 Wildfire Mitigation Plan Update – Group 1 Electrical Corporations

The Office of Energy Infrastructure Safety (Energy Safety) is revising its 2025 Wildfire Mitigation Plan (WMP) Update schedule for Group 1 electrical corporations.¹ The revised schedule a) extends the timeframe for Energy Safety’s issuance of draft Decisions; and b) provides an additional comment period for supplemental reportable updates.

The Group 1 electrical corporations were required to submit their 2025 WMP Updates on April 2, 2024.² During its evaluations of the initial submissions, Energy Safety identified multiple instances in which Group 1 electrical corporations did not follow Energy Safety’s 2025 WMP Update Guidelines,³ resulting in incomplete and/or erroneous submissions. As a result, Energy Safety provided two Group 1 electrical corporations with errata requests and one with a Rejection and Order to Resubmit. The erroneous and incomplete submissions impacted Energy Safety’s ability to timely issue draft Decisions on Group 1 electrical corporations’ 2025 WMP Updates.

Furthermore, Energy Safety is permitting San Diego Gas & Electric Company (SDG&E) and Pacific Gas and Electric Company (PG&E) to submit supplemental reportable updates for 2025 to account for the effects of Change Order Decisions issued after 2025 WMP Update submissions.^{4,5} SDG&E and PG&E supplemental reportable updates are due on July 5, 2024. Public comments will be accepted on those supplemental reportable updates through July 21, 2024. Reply comments will not be considered.
