I, Jordan Parrillo, do declare as follows:

1. I am a Manager of Rates and Regulatory Affairs for Liberty Utilities (CalPeco Electric) LLC ("Liberty"). I have reviewed Liberty's 2023-2025 Wildfire Mitigation Plan (WMP), submitted concurrently herewith. I am personally familiar with the facts in this Declaration and, if called upon to testify, I could and would testify to the following based upon my personal knowledge and/or information and belief.

2. I hereby provide this Declaration pursuant to California Code or Regulations Section 29200 to demonstrate that the confidential information (Protected Information) provided in the WMP is within the scope of data protected as confidential under applicable law. Attachment A to this Declaration discusses the relevant provisions of law that allow the Office of Energy Infrastructure Safety to maintain the confidentiality of the Protected Information. The Protected Information is also confidential pursuant to California Public Utilities Commission Decision (D.) 17-09-023 and General Order (GO) 66-D Revision 1.<sup>1</sup>

3. Based on my knowledge, the Protected Information being provided has not been made public in this form. Liberty is simultaneously providing a copy of its 2023-2025 WMP with the Protected Information redacted as part of its non-confidential submission.

4. In accordance with the narrative justification described in Attachment A, the Protected Information should be protected from public disclosure indefinitely, because neither the Protected Information, nor its sensitive nature are projected to change at any time.
