Each electrical corporation must submit its Safety Certification Request on the assigned submission date specified in Table 1. Requests submitted prior to the submission date will not be accepted.

Any deadline that falls on a weekend or holiday will be moved to the following business day. If a document is submitted during business hours, it will be deemed received on the date
