NOTICE OF VIOLATION

Mr. Berreth:

Pursuant to Public Utilities Code section 326 and Government Code section 15475.1, the Office of Energy Infrastructure Safety (Energy Safety) has conducted an inspection of work completed by PacifiCorp in accordance with its 2024 Wildfire Mitigation Plan (WMP) and determined the existence of one or more violations. Energy Safety therefore issues a Notice of Violation (NOV), identifying noncompliance with an approved WMP or any law, regulation, or guideline within the authority of the Office.¹

On December 19, 2024, Energy Safety conducted inspections of PacifiCorp's WMP initiatives in the vicinity of the city of Mount Shasta. The inspection report is enclosed herewith. Energy Safety found the following violation:

Violation 1. Energy Safety observed that in implementing 2024 WMP initiative 8.2.3.2 – Clearance, PacificCorp failed to adhere to protocol in achieving required clearance at pole ID 084601, at coordinates 41.32914242, -122.33553481 in High Fire Threat District (HFTD) Tier 2. Energy Safety considers this violation to be in the "Minor" risk category.

Response Options

In accordance with Energy Safety Guidelines,² within 30 days from the issuance of this NOV, PacifiCorp must provide a response informing Energy Safety of corrective actions taken or planned to remedy the above identified violation and prevent recurrence. Alternatively, should PacifiCorp disagree with the NOV, PacifiCorp must submit to Energy Safety a response stating it disagrees with the violation, the reason or justification for

the disagreement and all supporting documentation.³ This response shall be filed in the Energy Safety e-Filing system under the 2024 NOV Docket⁴ and the associated file name(s) must begin with the NOV identification number provided above.

PacifiCorp may also request an informal conference with Energy Safety's Environmental Science Division for the purpose of disputing any issues raised in this NOV no later than five (5) business days before the 30- day response deadline. Requests for informal conference with Energy Safety must be e-mailed to environmentalscience@energysafety.ca.gov, with a copy sent to Elizabeth.McAlpine@energysafety.ca.gov. Pursuant to Government Code section 15475.4, if PacifiCorp intends to request a hearing "to take public comment or present additional information," it must also do so within the 30-day timeframe. If a petition for hearing is not received by the deadline, then the determination and conditions set forth in this NOV become final.

Pursuant to Public Utilities Code section 8389(g), Energy Safety may refer this matter to the California Public Utilities Commission for consideration of potential enforcement action.

INSPECTION REPORT

Overview

Inspection Categories

The Office of Energy Infrastructure Safety (Energy Safety) conducts inspections to verify the work performed by an electrical corporation as reported in an approved Wildfire Mitigation Plan (WMP) or subsequent filing, and to assess general conditions of electrical infrastructure that may adversely impact an electrical corporation's wildfire risk. A Notice of Violation (NOV) is issued for any instances of noncompliance discovered during an inspection related to an electrical corporation's execution of its WMP initiatives.

Energy Safety has designated this violation as minor risk. PacifiCorp must correct the violation pursuant to the timeline provided in Table 1^6 .

Inspection Findings

Violation 1:

Relevant Requirement:

PacifiCorp's WMP states the following regarding initiative number 8.2.3.2 Clearance: "Pacific Power has adopted expanded post-work minimum clearance distances, of at least 12 feet for all distribution lines and has increased post-work clearance distances to 30 feet for transmission lines greater than or equal to 115 kV but less than 230 kV."

PacifiCorp's WMP states the following regarding initiative number 8.2.2.1 Detailed Inspections and Management Practices for Vegetation Clearances around Distribution Electrical Lines and Equipment: "Detailed inspections for vegetation clearances around distribution electric lines in California are generally performed on a planned three-year cycle as part of the routine maintenance program."

Finding:

PacifiCorp reported that work to achieve 12-foot radical clearance distance for the vegetation clearance program (WMP initiative number 8.2.3.2) under pole ID 084601 had been completed. According to PacifiCorp's DR 291, a white fir (*Abies concolor*) along the primary conductor was trimmed in August 2024. Near GPS coordinates 41.32914242, -122.33553481, the inspector observed a white fir with lateral branches within 12 feet of the conductor. The inspector measured the distance between the white fir and the conductor with a Nikon Forestry Pro II laser rangefinder and confirmed the branches overhanging the lines measured 5.9 feet above the conductor within the "Minimum Clearance Distance" of 12 feet as outlined in the WMP. The inspector's observation is documented in Violation 1 photographs, which are exhibits to this report. Photo numbers Item1Glmg1, Item1Glmg2, Item1Glmg3, Item1Glmg4, Item1Glmg5, Item1Glmg6 show that reported work at the location did not meet the 12-foot clearance requirement.

Energy Safety concludes that Violation 1 is "Minor" because the growth rate for the white fir indicates it should not grow into the conductor before the 12-month mitigation timeframe but should be remediated prior to the next planned routine maintenance program inspection in 3 years.
