15	Top Risk Circuit Scores	<b>No “Blank Meaning” column in the table.</b> PacifiCorp is currently developing the risk assessment tools as part of its 2023-2025 WMP and anticipates the calculation of the “PSPS Risk” components will be completed in 2024, therefore PacifiCorp anticipates “PSPS Risk” and “Overall Utility Risk” will be provided in the Q4 2024 QDR.
