SACRAMENTO - The Office of Energy Infrastructure Safety (Energy Safety) will hold a virtual public meeting (via Teams) for adoption of its Revised Draft Data Guidelines 4.0, Feb. 28 at 10 a.m.

Energy Safety’s data guidelines ensure that California’s electrical corporations submit uniform information for Wildfire Mitigation Plan (WMP) evaluation and compliance. Energy Safety will present an overview of the changes to the guidelines and take public comment.
