# OVERVIEW OF ENERGY SAFETY POLICY DIVISION PROCESS GUIDELINES (1 OF 3)



- Energy Safety has authority under Government Code section 15475.6 to “adopt guidelines setting forth the requirements, format, timing, and any other matters required to exercise its powers, perform its duties, and meet its responsibilities...”
- Several processes and documents overlap across the Electrical Safety Policy Division (ESPD) workstreams
  - WMPs, Safety Culture Assessments, Safety Certifications, Executive Compensation, etc.
- This new Guidelines document covers the processes related to all ESPD workstreams
  - Format, Data Requests, Errata, Naming Conventions, etc.

# OVERVIEW OF ENERGY SAFETY POLICY DIVISION PROCESS GUIDELINES (2 OF 3)

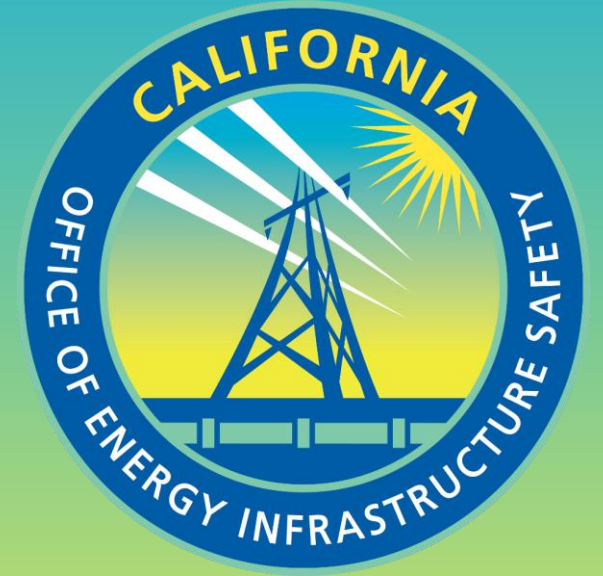


- For specified workstreams below, these guidelines will become effective beginning with the listed submissions and remain in effect until superseded:
  - 2024 Safety Culture Assessments
  - 2025 Executive Compensation
  - 2025 Safety Certifications
  - 2026-2028 Base WMPs
- Additional process requirements specific to a workstream are set forth in the workstream-specific guidelines

  - *GPI written comment*
- Corrected formatting and syntax errors
