

OVERVIEW



The **Maturity Model** is:

- A quantitative method to assess EC wildfire risk mitigation capabilities and examine how ECs propose to continuously improve in key areas of the WMP
 - Organized into 7 categories with 38 total capabilities

The three main objectives of the Maturity Model are:


- 1. Provide a tool to measure an EC's maturity in mitigating wildfire and outage risk
- 2. Drive year-over-year continual improvement
- 3. Create a quantitative history of EC maturity growth for examination in future years


The **Maturity Survey** is an Excel workbook tool to enable an EC to report its existing and planned maturity level for each sub-capability of the Maturity Model

PRIMARY CHANGES/UPDATES



- Scoring concepts remains the same as previous iteration
- Changes to MM/MS Guidelines
 - Added one capability (Best Management Practices for Transmission Rightof-Ways)
 - Edited and removed portions of sub-capabilities to improve clarity and reduce overlap
- Changes to Maturity Survey
 - Now an Excel tool for ECs to fill out and submit to Energy Safety
 - Changed to reflect the modifications made to the Maturity Model
