### Violations:

WJ Landscape Maintenance, Inc.

Government Code § 4216.2(b): Excavating without notifying the Regional Notification Center prior to excavation.

Government Code § 4216.4(c)(2): Failure to contact 911 emergency services upon causing damage to a subsurface gas facility.

Government Code § 4216.4(c)(3), (4); Cal. Code Regs., title 19, § 4100(a): Failure to notify the Regional Notification Center of excavation damage to a natural gas facility within two hours of the damage.

### Executive Summary:

On May 31, 2023, at approximately 9:00 a.m., WJ Landscape Maintenance, Inc., was excavating a trench in the driveway area at 999 Buckingham Place, Pasadena, California 91105, when it damaged an unmarked gas facility. WJ Landscape Maintenance, Inc., excavated and damaged the utility prior to notifying the Regional Notification Center.

WJ Landscape Maintenance, Inc., contacted Southern California Gas Company to notify them of the damage it had caused to their subsurface gas facility.

WJ Landscape Maintenance, Inc., did not contact 911 after causing the damage to the subsurface gas facility.

WJ Landscape Maintenance, Inc., notified the Regional Notification Center after damaging the subsurface gas facility but not within the two-hour mandated period.

No one interviewed in the investigation was able to provide photographs of this incident.

# Investigation:

# **Notification of the Incident**

On May 31, 2023, at 2:01 p.m., WJ Landscape Maintenance, Inc., (WJ Landscape) reported to the Underground Safety Board that "while digging a trench the trencher hit and damaged a gas line." This notification stated that at approximately 10:00 a.m., on May 31, 2023, WJ Landscape damaged a gas line while digging a trench at 999 Buckingham Place, Pasadena, California 91105. (Exh. 1.)

This case was assigned to Investigator Jeff McClenahan (Investigator).

# **Identity Of the Excavator**

Government Code section 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust, public agency, or other entity that, with their, or his or her, own employees or equipment performs any excavation."

On May 31, 2023, at 2:01 p.m., WJ Landscape "self-reported" the damage to the Underground Safety Board. The notification stated that at approximately 10:00 a.m., on May 31, 2023, WJ Landscape damaged a gas line while digging a trench at 999 Buckingham Place, Pasadena,

California 91105. (Exh. 1.)

On June 14, 2023, the Investigator had a telephone interview with Amanda Ibbetson, Office Manager of WJ Landscape, wherein the investigator asked if, "You created the ticket?" In summary, Ibbetson responded that:

- The reporting of damage and the creation of the ticket occurred at the same time.
- It wasn't created in advance, didn't know they had started.
- Boss usually tells me to create the ticket and then do the DigAlert. (Exh. 2.)

During a telephone interview with Investigator on July 19, 2023, Will Jameson, President of WJ Landscape, said:

- Trenching to install drain lines.
- Had been working there for a few days, wasn't first or last day.
- After the Southern California Gas Company responded to the damaged ½" plastic gas facility, the representative of Southern California Gas Company said there was no ticket on file. So, they went to get the ticket as they had already been doing the work prior to getting the ticket. (Exh. 3.)

WJ Landscape, was a licensed contractor with the Contractors State License Board, as of June 21, 2023, operating under license number 1063446, with a C27-Landscaping Classification. (Exh. 4.)

# **Identity of the Operator**

Government Code section 4216(o) defines an operator to be "any person, corporation, partnership, business trust, public agency, or other entity that owns, operates, or maintains a subsurface installation."

In its Emergency Incident Report No. 20230531-092000, Southern California Gas Company identified that they had personnel at 999 Buckingham Place, Pasadena, to respond to the damaged gas facility on May 31, 2023. (Exh. 5.)

# WJ Landscape Maintenance, Inc., Did Not Notify the Regional Notification Center Prior to Excavation

Government Code section 4216.2(b) states that an excavator planning to excavate shall notify the appropriate regional notification center of the excavator's intent to excavate at least two working days, and not more than 14 calendar days, before beginning that excavation.

During a telephone interview with Investigator on July 19, 2023, Will Jameson, President of WJ Landscape, said that after the Southern California Gas Company responded to the damaged ½" plastic gas facility on May 31, 2023, the representative of Southern California Gas Company said there was no ticket on file. So, they went to get the ticket. (Exh. 3.)

On June 2 and July 27, 2023, 2023, Investigator emailed DigAlert requesting a ticket search for 999 Buckingham Place, Pasadena California 91105 in the last year and the last known ticket at that address. (Exh. 6.)

On June 2 and July 2, 2023, Investigator received an email from Amber Dahl, Safety Awareness Director at DigAlert with the last known ticket at that approximate address, prior to the ticket created by WJ Landscape, on the day of the damage, which was from November 2020. (Exh. 8, 9.)

Will Jameson, President of WJ Landscape, requested ticket B231510881-00B at 2:10 p.m. on May 31, 2023, for trenching work for the homeowner. (Exh. 9.) This ticket was created after the damage to the subsurface gas facility.

# WJ Landscape Maintenance, Inc., Did Not Contact 911 After Damaging a Subsurface Gas Facility

Government Code section 4216.4(c)(2) requires an excavator to report damage to gas and hazardous liquid pipelines to 911 upon causing or discovering the damage.

On June 14, 2023, the Investigator conducted a telephone interview with Amanda Ibbetson, Office Manager of WJ Landscape. The investigator asked, "Did you call 911?" and Ibbetson responded "no." Ibbetson stated further, in summary, that this was because they had stopped working, crimped the line, and were waiting. (Exh. 2.)

# WJ Landscape Maintenance, Inc., Did Not Notify the Regional Notification Center of Excavation Damage to a Subsurface Gas Facility Within Two Hours

Government Code section 4216.4(c)(3) requires an excavator to notify the regional notification center within 48 hours of discovering or causing damage to a subsurface installation. Further, sub-section (c)(4) gives the Board authority "to impose more restrictive notification windows" than those imposed by the statute. The Board has done so in California Code of Regulations, title 19, section 4100(a), which requires an excavator with knowledge of damage to a natural gas subsurface installation to notify the regional notification center of the excavation damage no later than 2 hours after the damage to natural gas or hazardous liquid pipelines.

Ticket B231510881-00B for excavation at 999 Buckingham Place, Pasadena, California 91105, at was created by the regional notification center at 2:10 p.m. on May 31, 2023, more than four hours after the approximate 10:00 a.m. damage time to the subsurface ½" plastic gas facility by WJ Landscape. (Exh. 9.)

### Findings:

- 1. WJ Landscape Maintenance, Inc., did not notify the Regional Notification Center prior to excavation at 999 Buckingham Place, Pasadena California 91105 on May 31, 2023.
- 2. WJ Landscape Maintenance, Inc., did not contact 911 after it damaged a subsurface gas facility.
- 3. WJ Landscape Maintenance, Inc., did not notify the Regional Notification Center of excavation damage to a subsurface gas facility within two hours of the damage.

Yes, had cut through almost the entire line. Crimped the line and then waited for Southern Califorina Gas. Supervisor waited and stopped working. Supervisor waited until someone came for the repairs.

#### And that supervisor was Fernando?

That was Fernando.

#### You said they cut through almost the entire time, do you know what they were working with?

Leveling and digging but not sure if working with a bobcat or a trencher.

#### Anything else you can recall?

No, that's about all.

#### I will follow up with an information request and will ask after photos to help understand what happened.

Fernando title: Landscape Foreman Will Jameson title: President

Years of experience in landscaping Will: 18 years Fernando: 10 years

We are talking about the 999 Buckingham Place utility damage on May 31 2023 Yes.

Will you stated this was installing. Fernando: Trenching install drain lines. PVC storm drains here.

Regular type of work installing these as a landscape company? Will: Part of many things that we do.

What day did you start this project? Fernando: When happened had been working there a few days, wasn't first or last day.

How long was this project planned to take? Will: Different components. Drainage was 2 weeks. Overall time on this project was 3 months.

And this project was for the homeowner? Will: Correct.

On site for the entirety of this project? Lead crew in installing drainage system.

What equipment in use for the drainage installation?

Fernando: Shovels, picks, and trenching machine.

What kind of trenching machine

Ditch Witch walk behind trencher. To untrained eye looks like a big saw on front of machine. Chain goes around and as goes around it digs a trench.

About how deep can that go? Can go to 18". In this case going down 6".

Where were you working on this? Will: Was in soil and previously a driveway area. So concrete area had been removed and excavating in soil.

Were you working from maps or any old utility marks? Drainage plan as far as what we were installing. Existing gas line had been marked from the street to the meter.

When do you think that was marked?

There were two other contractors working the site at the same time. Don't know if they did or if the client themselves did.

So at the time of the utility damage there were utility marks on the ground? Yes.

Then WJ Landscape called in a ticket that afternoon. Correct.

Why call in the ticket that afternoon?

Will: SoCal Gas said no ticket on file. So went to get the ticket. Had already been doing the work prior to getting the ticket ourself.

Were there other utilities in addition to the gas that were marked? No, there were not any others. Will: Other than what was painted on the dirt prior to dig, no others.

Paint was sprayed onto the dirt where you were working? Yes.

Did the drainage plan include any existing utilities on it? No.

Talk through the work, damage, and repairs; what happened?

Had been trenching a few days prior, had been trenching in area of gas line. Knew that it was there from the paint markings. Under impression that most gas lines were 24" below grade. As trenching, trenching with confidence the line was deeper. Trencher caught existing gas line and pulled up and cut it. AT which point stopped working and bent the gas line to stop the gas from coming out. Then called the office to report it to SoCal Gas.

Call 911? Was there an emergency response? No. Just the gas company representative came out. Who was operating the trencher? Fernando.

Amanda called SoCal Gas? Yes.

About how long for the utility company gas to come out? About 20 minutes.

Did SoCal Gas provide any more info about the utility or mark other facilities in the area? Yes. They marked the rest of the gas line locations. And a water line location was marked.

So there were gas line areas that were not marked prior to the damage? Yes.

Continuing work on that site? Drainage work about 2 more days.

Did you communicate with Pasadena Public Works about the EPR issue? No, wasn't aware of that. Not aware of any other communication from Pasadena nor us with them.

The other work on the property what was with that? Swimming pool, landscaping with plants and irrigation systems, and home remodel.

Do you know who the other contractors were on site? One I think is called Perez Structural Construction, Crystal Clear Pool and Spa.

Take any photos of the utility marks or damage or anything like that? No.

Will: Looked as well and don't have anything.

Did you communicate with SoCal Gas on site? Yes, showed them where the line was.

Anything else that you both would like to share regarding this project? No, that's it.
