Executive Summary:

On November 29, 2023, Mark Caballero Pools and Spa, Inc., was trenching with shovels when they struck a plastic natural gas facility at 1925 Park Street in Huntington Beach, California. Caballero Pools did not contact the regional notification center before digging. After damaging the gas line, Caballero Pools contacted the regional notification center, which created ticket A233330415-00A.

Caballero Pools did not contact 911 or notify the regional notification center of the damage.

Two members on ticket A233330415-00A did not provide an electronic positive response prior to the legal excavation start date and time of the ticket.

No injuries or fatalities occurred because of damage to the gas line.

Investigation:

Notification of the Incident

On December 11, 2023, the Underground Safety Board Case Management System received damage notification number 23NTS004 from the Southern California Gas Company. The notification stated on November 29, 2023, Southern California Gas Company learned that Caballero Pools and Spa damaged a natural gas facility with shovels at 1925 Park Street in Huntington Beach, California. (Exh. 1.)

The case was assigned to Jeff McClenahan (Investigator).

Identity of the Excavator

Government Code § 4216(h) defines an excavator to be "any person, firm, contractor or subcontractor, owner, operator, utility, association, corporation, partnership, business trust,

public agency, or other entity that, with their, or his or her, own employees or equipment performs any excavation."

Mark Caballero Pools and Spa, Inc., is currently licensed by the Contractor's State License Board, license number 923171 for the C-53 Swimming Pool classification. (Exh. 2.)

Excavation and Damage

On November 29, 2023, an employee of Caballero Pools was digging to a depth of approximately 15" depth with a shovel when they struck a plastic natural gas service facility owned by Southern California Gas Company. (Exhs. 1 and 3.)

Cabellero stated that the homeowner contacted Southern California Gas Company following the damage. (Exh. 3.)

<u>Caballero Pools did not notify the regional notification center of the excavation to install</u> <u>the spa connection</u>

Government code section 4216.2(b) requires an excavator to notify the regional notification center of planned excavation unless an emergency exists.

In an interview with the investigator, Mark Caballero stated Caballero Pools did not notify the regional notification center of the excavation at 1925 Park Street. (Exh. 3.)

Caballero stated they generally notify the regional notification center when excavating in backyards and consider this a minor trench. (Exh. 3.) Caballero also stated he notified the regional notification center following the damage and received USA ticket A233330415-00A. (Exh. 3.)

At the investigator's request, DigAlert searched for tickets for 1925 Park Street in Huntington Beach between October 1, 2023 and December 31, 2023. The search results confirmed Caballero's statement that DigAlert did not create a ticket for Caballero Pools before the date that Caballero Pools damaged the gas line. (Exh. 4.)

Mark Caballero Pools and Spa, Inc. did not call 911 or notify the regional notification center of the natural gas facility damage

Government Code section 4216.4(c)(2) requires an excavator to call 911 upon causing or discovering damage to a gas facility.

Government Code section 4216.4(c)(3) requires an excavator to notify the regional notification center upon discovering or causing damage to a subsurface installation.

California Code of Regulations title 19 section 4100(a)(1) requires an excavator to notify the regional notification center of damage to a natural gas facility within 2 hours of the damage.

Regarding the requirement that Caballero Pools contact 911, Caballero stated that he was not aware of a 911 response after the natural gas damage. (Exh. 3.) Further, no other information obtained during the investigation indicates that Caballero Pools contacted 911.

Caballero stated that after the damage occurred, he contacted DigAlert. (Exh. 3.) Caballero did not state whether he notified DigAlert of the damage to the line at that time. For that reason, the investigator obtained from DigAlert the audio of Mark Caballero's phone call with a DigAlert representative after the damage occurred.¹ The audio recording is attached to this report as Exhibit 14. The investigator transcribed the call, and the transcription is attached to this report as Exhibit 15. When Caballero called, DigAlert created ticket number A233330415-00A. (Exh. 4.) During the call, Caballero did not inform DigAlert that Caballero Pools, or anyone, had damaged the natural gas line. (Exhs. 14, 15)

<u>The City of Huntington Beach and the City of Huntington Beach Fire Department did not</u> <u>provide an electronic positive response to the ticket prior to the legal excavation start</u> <u>date and time</u>

Government code section 4216.3(c)(1)(A) requires an operator to provide an electronic positive response to the excavator before the legal start date and time of a ticket.

Mark Caballero contacted DigAlert, which created ticket A233330415-00A for a gas line replacement at 1925 Park Street. The ticket indicated that a response from operators was required. (Exh. 4) The legal excavation start date and time for Ticket A233330415-00A was December 1, 2023, at 5:01 p.m. (Exh. 4)

On December 1, 2023, at 5:01 p.m., the City of Huntington Beach Fire Department (Member code HBFD) received late notice electronic positive response code 999 from the regional notification center. (Exh. 4)

On December 1, 2023 at 5:01 p.m., the City of Huntington Beach (Member code HUN03) received late notice electronic positive response code 999 from the regional notification center. (Exh. 4)

On August 26, 2024, Amber Dahl, DigAlert Safety Director, confirmed the contact information for the City of Huntington Beach and the City of Huntington Beach Fire Department. (Exh. 5.) The contact information for the City of Huntington Beach Fire Department had two different contact names associated with the email and the phone number. (Exh. 5.)

¹ Amber Dahl of DigAlert transmitted the audio file of the recording to the investigator by email on December 27, 2024. (Exh. 12 (email); Exh. 13 (transmittal letter).)

On August 27, 2024, the investigator sent an information request to the City of Huntington Beach Fire Department and the City of Huntington Beach regarding their electronic positive responses to Ticket A233330415-00A. (Exhs. 6, 8, 10, 11.) Neither operator responded to the information request.

On September 17, 2024, the investigator sent a second information request to the City of Huntington Beach Fire Department and the City of Huntington Beach. (Exhs. 7, 9, 10, 11.) Neither operator responded to the second information request.

On September 17, 2024, the investigator left a voicemail for the contact of the City of Huntington Beach to follow-up on the information request.

On September 17, 2024 and September 18, 2024, the investigator called the contact for the City of Huntington Beach Fire Department and received the message that the voicemail box was unable to be completed as entered and the line was in use.

The investigator did not receive a response from either the City of Huntington Beach or the City of Huntington Beach Fire Department.

Findings:

- 1. Mark Caballero Pools and Spa, Inc., did not notify the regional notification center before Caballero Pools and Spa, Inc., dug while installing a spa connection at 1925 Park Street in Huntington Beach California on November 29, 2023.
- 2. Mark Caballero Pools and Spa, Inc., did not contact 911 following the damage to the natural gas facility.
- 3. Mark Caballero Pools and Spa, Inc., did not notify the regional notification center of the damage to the natural gas facility.
- 4. City of Huntington Beach Fire Department was required to respond to ticket A233330415-00A but did not provide an electronic positive response. Further, the operator did not respond to requests for information regarding the failure to provide an electronic positive response.
- 5. City of Huntington Beach was required to respond to ticket A233330415-00A but did not provide an electronic positive response. Further, the operator did not respond to requests for information regarding the failure to provide an electronic positive response.





M: No, I'll see it on the confirmation. Thank you.

L: You're welcome. Your ticket number, which is active for 28 calendar days from today, is A like Apple, 2-3-3-3-0-4-1-5.

M: You said A-2-3-3-3-0-4-1-5?

L: Correct. If your work is continuing, you must renew your ticket on or before December 27th. California Government Code states excavation may not begin until all members have responded. Members must respond via electronic positive response, and responses can be viewed on DigAlert.org or our mobile apps. After the members have responded, the law requires the excavator to notify DigAlert if the members marks are no longer reasonably visible.
