Executive Summary:

On October 23, 2023, Patriot Construction Services used shovels to move dirt covering a utility vault located approximately 18 inches underground. Patriot was working on behalf of the vault's owner, the Zayo Group, and did not contact USA North before moving the dirt.

That same day, after speaking to Kinder Morgan personnel, Patriot contacted USA North, which created a ticket relating to the work. Patriot maintains that it did not need to contact USA North because moving the dirt was not excavation because the Zayo Group had a right to access the vault, and because there was no need to ask other operators to field mark the work area.

Notification from AT&T

AT&T submitted the following notification on October 23, 2023:

CONTRACTOR WAS CAUGHT DIGGING BY KINDER MORGAN WITHOUT A TICKET (PER CONVERSATION WITH KM). A FEW DAYS PRIOR. THEY THEN CREATED A TICKET AND ATT (US) CAME OUT TO MARK AND FOUND THAT CONTRACTOR

HAD DUG DIRECTLY ABOVE US. APPROXIMATELY 2' MORE AND THEY WOULD HAVE STRUCK OUR TRANSMISSION LINE. PICTURES SHOW OUR FLAGS AND MARKS THAT WE PLACED IN THE PIT UPON DISCOVERY OF DIG VIOLATION. TKT 2023102300626-000. I HAVE PICTURES YOU CAN REQUEST IF NEEDED. THEY WON'T UPLOAD. (Exh.1.)

The case was assigned to Jeff McClenahan (Investigator).

<u>Patriot Construction Services Used Hand Tools to Move Dirt to Reach a Buried Utility Vault Without First Notifying USA North</u>

Government Code section 4216(g) defines excavation to be "[a]ny operation in which earth, rock, or other material in the ground is moved, removed, or otherwise displaced by means of tools, equipment, or explosives in any of the following ways: grading, trenching, digging, ditching, drilling, augering, tunneling, scraping, cable or pipe plowing and driving, or any other way."

Eric Russo, Chief Executive Officer of Patriot Construction Services (Exh. 8.), stated that Patriot personnel used hand tools to remove approximately a foot and a half of uncompacted soil to reach a buried utility vault (Exh. 3) that was near a railroad track and Roseville Road in Sacramento County. (Exh. 6.) Photographs taken by Frank Ruiz of AT&T of the hole Russo dug are attached as Exhibit 4 to this report (Exh. 4.).

Russo stated that the utility vault belonged to the Zayo Group and that Patriot was performing work on lines that ran through the box Patriot was uncovering because the company "X" (formerly "Twitter") had "fiber trouble." (Exh. 3.)

Patriot Construction Did Not Notify USA North Before Moving the Dirt

Government Code section 4216.2(b) requires an excavator, except in an emergency, to notify the regional notification center of the excavator's intent to excavate at least two working days before beginning excavation. Government Code section 4216.2(e) requires the regional notification center to "provide a ticket to the person who contacts the center" and to "notify any member, if known, who has a subsurface installation within the area of the proposed excavation." Government Code section 4216.2(g) provides that "[u]nless an emergency exists, an excavator shall not begin excavation until the excavator receives a response from all known operators...."

Russo stated that Patriot Construction Services did not contact USA North before moving the dirt covering the vault for three reasons. One, moving the dirt that covered the vault was not "excavation" which required Patriot to contact USA North. Two, the company Zayo contracted with Patriot to perform the work. Zayo owns the vault and has the right to access the vault to service utilities that run through it. Third, Patriot knew exactly where the vault was located, so it was not necessary for other operators to locate and mark the area.

Regarding whether moving the dirt was "excavation," Russo stated that Patriot 'was not mechanically digging, just clearing the top of the lid,' and that Patriot 'was not excavating into anything.' (Exh. 3.) Further, Patriot used hand tools to move the dirt and only went down a foot and a half. (Exh. 3.)

Regarding Zayo's right to access the vault, Russo stated, 'we have to be able to work on and maintain public utilities. Uncompacted dirt is put back in the hole, it will never be compacted, and the vault will need to be accessed again.' (Exh. 3.) Zayo has a right to access the vault. (Exh. 3.)

Regarding a need for other operators to respond to a locate required, Russo stated that moving the dirt to access the vault did not create a danger to nearby subsurface installations because Patriot knew exactly where the vault was and moved the soil above the vault with hand shovels. (Exh. 5.) To have contacted the call center would have caused the other operators to locate and mark the area, which was not necessary, and it would have been 'discourteous to do that to everyone in the industry.' (Exh. 5.) Russo determined where the vault was because Zayo covers its vaults with 18 inches of uncompacted dirt and leaves markers. Also, Russo had an engineering plan and used a locator and probe. (Exh. 3.) Russo stated that the outside edge of the vault is 9 feet and 7 inches away from Kinder Morgan's line. (Exh. 3.)

Patriot Contacted the Call Center at the Request of Kinder Morgan

Russo stated that Kinder Morgan flew over the location where Patriot was working and then sent a field representative to the site. That representative told Russo that Patriot should call in a ticket. For that reason, Patriot contacted USA North on October 23, 2023, (Exh. 5), which created ticket number 2023102300626-000 that same date. (Exhs. 6, 9.) The ticket indicates that Patriot included this statement in the "Excavator Remarks" section: "There are three buried utility vaults we are trying to access," (Exh. 6) and that the excavation method is "Mechanical/Multiple Methods." (Exh. 6.)

Patriot had already moved the dirt above the utility vault near the time that Patriot contacted USA North. AT&T received the notification from USA North and arrived to mark the site on October 23, the same day Patriot contacted USA North. (Exh. 7.) At that time, AT&T's personnel took two photos of the work area, the hole that Patriot dug, and the top of the vault. Those photos are attached as Exhibit. 4.

Finding:

1. On October 23, 2023, Patriot Construction Services moved dirt with shovels to expose the top of a buried utility vault. Patriot did not contact USA North before moving the dirt. On October 23, 2023, after moving the dirt, Patriot contacted USA North, which created ticket number 2023102300626-000.

Talk me through what happened?

Kinder Morgan was upset that we were digging up our box lid and said we have to notify them. This is a public utility corridor. Zayo Group has vaults and cover with 18" of dirt, don't compact it and leave markers. Had engineering plan and knew where it was and it was a 4x6 sunken in.

Have been doing this for 30 years over the US. Zayo, ATT, everyone else, only cover these so that there is no theft along the railroad. I used a locator to follow it. Check with EMP ball in it, probe down and box.

Called Zayo and said have a right to get into the utility, no different than anyone else. Not excavating into anything, have to check our splace case for this project.

Someone said was going to have us arrested because in right of way -- Kinder Morgan. Then said would have railroad arrest us, but is a private spur of McClellan Park.

We were not mechanically digging, just clearing top of lid.

Talked to Kinder Morgan supervisor and they said can call an emergency ticket. Then triggers all these utility companies come out, and we said we are not excavating.

Is this a typical project?

Would say all communication companies that follow rails, sink them because no one can steal the copper. Kinder Morgan person that spoke with us and said would have arrested. Zayo is a public utility, have a right to enter. Then Kinder Morgan said they have to be out there when we move plates.

Outside edge of the box is 9 feet 7 inches from their line.

You had plans with the existing utilities?

Yes had communication, gas, and gas is on the rail side other side.

Just says gas because is obviously there. ATT has buried marker there already.

These communication things are joint build, usually a series between 2 and 5 vaults. ATT will typically have 2, and MCI ducts will have one, Zayo in their vault were privately it was 360 Networks. All in a joint duct.

Not scaled but on the plans, gas looked between 10 and 15 feet away.

You said there were marker posts?

Marker posts for Kinder Morgan and ATT. Zayo will have a marker out there in the future too for this vault.

KM said you have to call us if you move these plates. It's not excavating; we have to be able to access and work on and maintain the public utilities.

Uncompacted dirt is put back in the hole, will never be compacted, will have to be accessed again.

And there is a marker ball?

Yead we trace from the manual to the first sub box, 2nd, 3rd etc... Even though can see the markers. White brand metal detector that will pick up those balls.

What equipment do you use?

The digging equipment, can't dig very hard, it is a fiberglass lid. Square point and round point to get to the lid. Hand tools. Only going down a foot and half.

Zayo doesn't typically use a ticket for this kind of work?

Correct, uncovering a known entity. Not digging a trench or adding facilities. Uncovering a known box. If adding facilities need pre-con meeting and ticket and communicate with other parties.

What kind of work were you doing on this project?

X had fiber trouble (previously Twitter). Trace out to a splice case, identify was in the box that said it was per the plan. And would try to switch fibers, call it rolling fibers, so take a different route etc.. Im' just the outside guy. Backtrace the fiber lines.

Kinder Morgan said if you have to get back into this again, you have to call us again. I recommended putting plates on it just to protect it for safety and from transients. o

They wanted us to call in a new ticket to excavate. Through the project will uncover 3-4 times. If decide to add fiber, then would pull through an existing conduit, no excavating either.

Kinder Morgan said you have to call every time you get in and out of this hole.

I see you have a few tickets out there; have you coordinated with any utilities out on Roseville Road before?

Replacing a lid still considered excavation. Have had a pre-con and standby from PGE before on another one, even though the lid was on surface level. Always call in a USA when do any kind of excavation.

This is all over the world. Sierra Pacific Railroad was big on it, started Quest Communications, their own communication company. Would do long haul cable plows and set up all these vaults along every single rail corridor.

In a certain amount of distance would have permit from railroad, notify trains schedule, etc... Because this was McLellan Park private spur, you don't have to do all that.

Do you have any photos of this project?

This is just a maintenance thing. Would be totally different if added a cable. We bill based on work performed if actually building anything for instance.

TTM is a trouble ticket with a damage. Potentially fiber outage etc... Then would have photos. If had USA then would photo the USA to prove USA'd it. Then have a pothole log and hydro excavate everything. Find all known utilities within 10 feet even if 2 is required.

If doing a remove and replace a vault then hydro vac all around it. So hydro is so much safer.

On this project, we started mapping the unknown sections before were provided with the plans. If have no as-bulits then is called an unknown, unforeseen.

Started the mapping? You did the work yourself? How do you go about that?

Have an address, have minimum point of entry, cable rooms where originates. Say on south wall, have 96 count fiber and then have 144 ofs cable and start backtracing and see if has tracer wire and follow to next mark. See if marked Zayo and I'm the guy who calls in the tickets and authorizes the digging.

And use locator for that?

Yeah, to follow that tracer wire.

At what point did you get the map with existing utilities?

About a week before the project had that, didn't care yet because had to see if everything before that came out correctly and aligned what the cables. Go the each one, open lids, pull it, trace it, if doesn't have tracer, will rod in and hook up and follow.

Industry practice we spoke about where you generally wouldn't call in a ticket, but I was able to find a ticket in this case. Why call in a ticket this time?

Talked to guy from KM said he said we could call an Emergency Ticket. But this is a known entity, no one can build above it, don't call it in because have to have 24/7 access to it because is long haul cable. I said if it makes you feel better I could call it in, but problem is that USA is for everyone to mark their facilities before you excavate, we know exactly what we are looking for and exactly where it is, and uncovering the topsoil with hand shovels. Discourteous to do that to everyone in industry because know this exactly.

So did you call in this ticket after speaking with Kinder Morgan?

Did this to make them happy, yeah. But also called that to Zayo that restricting us from getting in to their facilities and if a major outage and costs tens of thousands of dollars they will sue you.

Kinder Morgan has no right to prevent them from getting in to their public utilities. Just like Zayo can't tell Kinder Morgan to get in to their pipeline. And I'm stuck in the middle, but Zayo has responsibility to access and maintain the utilities.

Do you know how did you run in to the KM team out there?

They fly over their facilities with a plane, checking for work and transients digging near holes. They said saw the crew out there and called it and the field guy came out there.

So why would you not use an emergency or rush ticket?

If had a fiber outage along an unknown route then would call an emergency ticket. Because need to cover us and all the other utilities. Because will have t excavate because don't know where it is.

But why do all that when we know where it is? No different than a vault covered up with landscape. Why call USA to remove the topsoil and open the lid. If had to do any mechanical means then absolutely would call it in. What if have a hydraulic failure or operator failure or swing to side etc... This was located to the plan. Taxing resources if call this in that don't need help with this.

And on almost every ticket I have submitted, they never meet that legal deadline. Almost all of them.

Unrealistic expectations on companies, a lot of them subcontract it. Go over records and documentation, hook up and everything us. It is a big ask, utility companies that have to budget that. So I get it.

So have a ticket right now, supposed to be completed Wed., because of rain can't get out and mark, not my problem. But since then my marks were washed away. Par for the course. No system or process is perfect. Just because have paint on the ground have to do due diligence too.

Thanks for the notification; can you walk me through what happened?

Got the ticket for the locate. Looking for the dig site and found the site had already been dug up.

So you were on site too; how was David Rubio from your notification involved?

Met David Rubio of Kinder Morgan on site.

What day were you out there?

Same day as the ticket generated so would have been the 23rd.

And you took the photos you sent over?

Yes.

What did you see on site?

Saw cones and caution tape around the area. Saw the excavation area. Saw a medium pit about 3 feet deep with a concrete box below it. Used my locator to search and found my utility was right below that box.

How did you mark that out your facility?

That was the orange flags out there in the phoot.

Did you speak with Patriot Construction?

Yes, they agreed they had started digging. They said they never make tickets for this kind of work.

Who did you speak with from Patriot?

The name on the ticket.

So Eric Russo?

Yes.

Did you speak about anything else?

Asked how much more work doing there. He said would be uncovering the dirt and that that would be it. I told him the facility was located.

What time were you out there?
